Hi Karen,

My Sgt asked if I would have a quick look at this for you.

Please find attached as much info as I could find re reported crimes for the period March 2015/ April 2016 And same period 2016/2017

Kidlington NHPT are aware of the issues on Cromwell way and have issued a number of tickets to those vehicles deemed to be causing an obstruction to the road.

Likewise with the new parking time limit on the Oxford Road slip road.

In total 7 tickets have been issued during 2016 to 2017 for cars causing an obstruction on Cromwell way and Fairfax.

With a further 10 tickets issued on the Service road. A number of tickets have been issued to cars on the other side of Oxford road on the slip road of a higher number than the Gosford side.

During the first 6 months of 2016 14 warning notices were issued to vehicles on Cromwell way for obstruction and inconsiderate parking.

Improvement works are ongoing within the HQ site to raise the number of parking spaces and the HQ team are fully aware of issues in the Cromwell way overflow and continue to advise visitors to be conscientious of our

**neighbor's. Part of any course invitation is a request to adopt car sharing and public transport links where appropriate to reduce the amount of traffic in the area. This obviously can't be enforced but is strongly advised.**

I hope this is of help and informative to your meeting. I sadly won't be able to attend as I will be on rest days on the day of your meeting.
