Morning All

For clarity the proposal for the 2017/8 precept is an increase from this years total of £18,690 to £44500. This is the number which we need to supply to Cherwell D.C.

Can we all please reply by the end of Sunday to this email stating whether we agree or disagree with this proposal being communicated to Cherwell as a budget figure subject to ratification at our next full council meeting

Currently, I believe that Emilie, Merlin and I agree with the proposal.

As a reminder this is an increase of just over 150%, but in cash terms is an increase from £33 to £83.58 per household, which is still less than the rest of Kidlington which last year was over £130.

The key to this significant rise is the expected extra cost of responding to the housing proposal, plus the others listed by Emilie below.
